**Name of Tender: Supply of Power Transformers.**

The Oil Projects Company (SCOP) of the Ministry of Oil, Baghdad, Iraq, announces the issuance of the above-mentioned Tender to be performed in two phases .

**Brief description:**

This requisition shall cover design and supply of M.V. power transformers (11/3.3 kv) , neutral earthing resistors (3.3 kv) and L.V. transformers ( 3.3 / 0.4 kv)

Country of origin of the materials shall be from USA , Japan , German , France , UK , Italy.

Tender documents may be collected (by an authorized representative of the tenderer) at SCOP's headquarter in Baghdad against the payment, non-refundable, of ID. ~~150,000,000~~.....

(One Hundred and Fifty ID Dinar).

**1. First phase**

Tenders shall be submitted in three (3) separate sealed envelopes as follows, each envelope should be a high quality, sealed with red wax and stamped by the company official stamp :

**1.1 Envelope (1) containing:**

The tenderer's previous experience and his qualifications duly legalized and authenticated by the Iraqi Embassy (or representation) in the country of registration of the company as below:-

1. The registration certificate of the company issued by the appropriate authority in the country of registration.
2. Documents defining the constitution of the company and the company's statute.
3. The preceding year's financial balance sheets.
4. The powers of attorney of its authorized representatives.
5. The bidder who will be awarded this tender shall bear the advertisement cost which should be paid by the contractor before signature of the contract.
6. Bidder shall be either a manufacturer or one of its legally certified agents.
7. A copy of the receipt for the purchase of the tender documents.

**1.2 Envelope (2) containing:-**

- The technical part of the offer without any indication of prices.
- The country/ countries of origin of the materials complete tender list.

**1.3 Envelope (3) containing:-**

- A non priced copy of the commercial part of the offer, with any other details that are Relevant to it.
- Any bidder's comments about the proposed form of contract and any other comments.

**2. Second phase**

The bidders who will satisfy all technical requirements and conditions of the bid shall be qualified at phase one and shall be instructed by SCOP at a defined deadline to submit the following required documents in a sealed envelope which should be a high quality, sealed with red wax and stamped by the company official stamp.

1. Their priced commercial offer according to the final technical details and conditions and revisions reached with SCOP .
2. preliminary deposit of (1%) of the offer price. It shall be in the form of a letter of guarantee or check issued by a Bank in Iraq.

- SCOP does not bind itself to accept the lowest tender.
- Bids will be neglected if the above mentioned documents are not complied with and attached.
- The deadline for receipt of the first phase bids is 12.00 noon on 14/06 /2011.
