1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, issue on 12 October, 2004
2. The Republic of Iraq has received the Iraq Trust Fund administered by the World Bank (hereinafter called "Grant") toward the cost of Emergency Water Supply, Sanitation And Urban Reconstruction Project (TF054455) and it intends to apply part of the proceeds of this Grant to payments under the Contract for: **Supply of fifteen (15) Wheel Loader Backhoes plus relevant spare parts.**
3. The Ministry of Municipalities and Public Works now invites sealed bids from eligible and qualified bidders for: **Supply of fifteen (15) wheel loader backhoes plus relevant spare parts; the delivery period shall be 210 - 270 days**
4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
5. Interested eligible bidders may obtain further information from Mr. Alaudeen Jassim, PMT office, Ministry of Municipalities and Public Works, Al mansour Baghdad, Republic of Iraq, and inspect the Bidding Documents at the address given below from 9:00 a.m. - 2:00 p.m. Baghdad local time.
6. Qualifications requirements include:
 - (a) **Financial Capability**
The bidder must submit audited statements of accounts for the last five (5) years demonstrating sound financial position. The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):
- Minimum average annual turnover in the last five [5] years: at least two (2) times amount of the bid subject of this bidding process.

- The working capital should be more than Thirty (30) percent of the Bid Price
- Annual financial reports of the last 2 years demonstrating sound financial position
- (b) **Experience and Technical Capacity**
The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):
 - (i) Overall experience of the firm in the supply of goods and related services.
 - (ii) The bidder should have at least ten (10) years of Specific experience as manufacturer or supplier of items similar to the required in its bid.
 - (iii): **The Bidder has successfully completed as main supplier of goods at least two (2) contracts of at least the scope of supply and complexity comparable to the one in this bid, over a five-year period ending on the deadline for bid submission.**
 - (iv) The Bidder must include in its bid names and contact number of previous clients and an official letter from each client certifying that the sold goods similar to the goods object of this bidding process are still in GOOD operating conditions since the purchase.
- (c) **Usage Requirements**
The Bidder shall furnish documentary evidence to demonstrate that the Goods it offers meet the following usage requirement as stated in the technical specifications in the Bid Documents .
A margin of preference for certain goods manufactured domestically shall not be applied.
- 7. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee US\$ 200. The method of payment will be paid in Cash or cashier's check, or direct deposit to specified account number. The Bidding Documents

will be picked-up from the PMT office or via mail and courier.

8. Bids must be delivered to the address below at or before 11:00 a.m. Baghdad local time on 12 March 2012. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person or on-line at the address below at 11:00 a.m. Baghdad local time on 12 March 2012
- All bids must be accompanied by a Bid Security of US\$ 20,000 (Twenty Thousand Dollar) and duration of validity of 148 days or an equivalent amount in a freely convertible currency issued by a reputable bank or financial institution selected by the bidder. If the institution issuing the security is located outside Iraq, it shall have a correspondent financial institution located in Iraq to make it enforceable. **The acceptable Iraqi Banks are the Governments Banks in addition to the Top Ten Iraqi Privet Banks certified by Central Bank of Iraq (List Attached)**"
