1. Brief description:

This tender shall cover supply 3 No. Diesel Generating Stand - by set 2 No. (750KVA) rating & 1 No. (500KVA) rating.

The country of origin materials should be from (USA, Germany, Japan, South Korea, France, and Canada).

2- Tender documents:

Tender documents may be collected (by an authorized representative of the tenderer) at SCOP's headquarter in Baghdad against the payment non-refundable (...250.000.000...ID) in writing (...Two hundred fifty thousand...).

Companies are required to submit the following documents duly legalized and authenticated by the Iraqi Embassy (or representation) in the country of registration of the company:

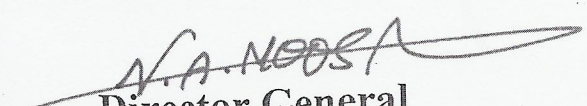
- 1- Document of institution of the foreign companies issued from chamber of commerce or industry approved by foreign ministry & Iraqi embassy at the same country.
- 2- Document of institution of Iraqi companies issued from companies register in trade ministry with valid discharge from tax office.
- 3- Authorization letter to the representative of company who purchase the tender.
- 4- The bidder who will be awarded this tender shall bear the advertisement cost which should be paid by the contract.
- 5- Bidder shall be either a manufacturer or one of its legally certified.
- 6- A copy of receipt for the purchase of the Tender Documents.

Notes:

• Tenders shall be submitted in five (5) envelopes as follows:

- Envelope (1) containing: Required documents.
- Envelope (2) containing: The technical offer + Time schedule.
- Envelope (3) containing:
 - The non-priced commercial offer.
 - Comments of contractor at the draft of contract.
- Envelope (4) containing:
 - The priced commercial offer.
 - Comments of contractor at the draft of contract.
- Envelope (5) containing: The Preliminary Deposit (bid bond) of one percent (1%) of the offered price. It shall be in the form of guarantee or check issued by a Bank in Iraq in separate sealed envelope with Request No. and name of company on it.

- The Company is unobliged to accept the lowest price.
- Bids will be neglected if the above mentioned document is not attached.
- The deadline for buying the bid is not later than 12.00 noon 26 / 3 /2014
- The deadline for receipt of the bids is not later than 12.00 noon 31 / 3 /2014
