General requirement: -

- 3- Tube ends should be covered by plastic caps.
- 4- Tube should be packed in wooden boxes seperatiy with weather proof (tarpaper) lining durable and suitable for overseas shipment and handling.
- 5- The delivered material without inspection authorities' issues, relevant reports, mill and originality certification will be unacceptable.
- 6- ALL material test and chemical composition report documents should be approved by the independent authorized third party inspection company which certify that all the materials passed the required tests successfully and comply with and meet the specifications of tender documents.
- 7- Chinese origin is unacceptable
- 8- origin certification should be stamped by Iraqi embassy in the origin country
