1- Terms & conditions for tender documents :

1-1 Iraqi companies and branches

1-1.1 Company foundation certificate (original copy) should be presented yearly – one time ratified by Iraqi trade ministry

1-1.2 The authorized person should have authorization letter concerning his right to submit offers under the name of mother company and this letter should be certified by notary office

1-2 Foreign companies

1-2.1 To submit (company foundation certificate , original copy one time yearly ratified by supplier foreign ministry and certified by Iraqi embassy in the same country

1-2.3 The authorized person should submit fully authorization letter (concerning his right to submit offers under the name of mother company) certificate by foreign company of the supplier and Iraqi embassy in the same country

1-2.5 Foreign company which based their branches , bureaux I Iraq are requested to submit their registration letter within Iraqi trade ministry ratified by companies registrar office

1-3-1 Original copy of company foundation certificate should be submitted inside one envelope with commercial offer

1-3-2 Copies of above certificate and authorization letter open page accepted

1-3-3 If the offers submitted by Iraqi agents companies the authorization should be issued from the manufacturer company, legalised from commercial attach or Iraqi embassy in the mother companies

2 Documents and conditions of offers:

2-1 A tender collecting document should be submitted otherwise the offers will be disregarded , and document price not refund except the price of the tender cancel by North Oil Company .

in case of re-declaration the first bid document bill should be enclosed with second declaration document and if any price increase in bids documents of second declaration the bidder should hold the extra price for this changing and the both bills should be presented .

2-2 Unconditioned bid bond , bank guarantee or certified check issued from / through any Iraqi reliable bank except (Warka Bank For Investment & Finance , Al-Belad Islamic Bank , Basra International Bank For Investment , Islamic Bank , Al- Huda Bank) , or debenture bond issued by Iraqi government with 1% of offer total amount in the name of the North Oil Company (NOC) must be submitted in a separate sealed envelope attached to the sealed commercial offer envelope and tender n^o , inquiry, n^o. - 2-3 Tax status from "the general tax office" and financial status should be submitted with the commercial offer for the Iraqi companies and foreign companies, branches, bureaus and official agents holding ratification of Iraqi trade ministry.
- 2-4 Brief overview should be presented for company activities attached with the commercial offer.
- 2-5 Offers should be in (2) separate parts technical & commercial with reference and date , each in (3) copies , enveloped & sealed with your company stamp & to be submitted or handed over to the Contracts department in Kirkuk , Arapha up to 12 o'clock of the closing date, and any offer reaches after this date and all offers received by e-mail will be disregarded .

7- **Taxes and Fees:**

7-1 Fees, taxes and the charges of the L/C opening outside Iraq and L/C amendment inside, outside Iraq relating to this contract should be paid by the bidder .

7-2 Iraqi companies, authorized companies, branches or representative bureaus shall be subject to Iraqi tax laws and regulations.

- 11- **Confidentiality :**
- 11-1 Any contract placed by north oil company shall be treated as confidential, and in particular the supplier shall not make use of the company's name (or the name of any companies associated therewith) for publicity purposes without the prior written consent of the company.
- 11-2 All designs, drawing, specifications and information which may be supplied in connection with the contract are confidential and shall only be used for the purpose of this purchase order.
- 11-3 This obligation of confidentiality shall be a continuing and lasting one and shall not be ended upon delivery, completion of services, nor affected by the termination of this purchase order.
- 12- **Audit :** The supplier shall maintain records of all transactions related to this contract for a period of not less than twenty-four (24) months after the final payment is made by company to supplier. The company shall have the right to audit all reimbursable costs and expenses related to this purchase order. Also through third party.
- 13- **Assignment and subcontracting:** The supplier shall not assign or subcontract any part of this contract to any other party or parties without the prior written approval of the company. Free charge copies of any such sub-contracts shall be supplied to the company on request.
- 14- **Force majeure:** In the event of force majeure beyond the reasonable control or power of both parties or general emergency cases that affect the fulfillment Of his contractual obligations partially or fully , both parties obligations will be deferred and prolonged for the time of the delay caused by such force majeure. And the affected party should inform the other party of an event of force majeure by world communications, and by the agreement of both parties.
