**1. SUBJECT**

Rehabilitation of Water treatment Plant in Hamam Al Alil, Mosul District, Nainawa Governorate.

**2. OBJECT**

The objective of the project is to rehabilitate the WTP and provide Hamam Al Alil town and neighbourhood Hamam Al Alil camp with a reliable source of drinking water for both residents and IDPs.

**TENDERING DOCUMENTS**

The present Call for Tender comprises:

- The Call for tender itself
- The Bill of Quantities
- The works specifications
- The general conditions of ICRC

**3. TENDERS**

It is **compulsory** to complete the following points to fulfil the tender requirements:

- **The present Call for Tender signed by both the Company and ICRC representative during the Site Visit.**
- The completed Bill of Quantities, with unit prices for each item.
- The Total cost of the offer.
- A detailed Work Schedule.
- A presentation & certification file, including:

- a) an introduction letter with company's or bureau's logo), name, address, phone no., email, bank account & branch, full first 3 names of director and a copy of valid ID :
  - ⇒ for **Companies** : Ministry of Planning & Developmental Cooperation -Iraqi Contractors Registration ID
  - ⇒ for **Bureaus** : Ministers' Counsel's Planning Committee - Iraqi Contractors' Registration ID or a registration from a governorate Chamber of Commerce for Contractors in a relevant field of activity (dealers & suppliers not accepted) or Iraqi Contractors Federation ID
- b) A copy of Director's or, if existing, representative's ID (passport or National ID).
- c) For **companies**, copy of Company Incorporation & Company Incorporation Certificate issued from the Ministry of Trade includes number & date of registration.
- d) **Technical specifications with the catalogs of the pumps, valves, pre-sedimentation tanks, in addition to the supplier's pump efficiency curve for the pumps.**
- e) If worked for ICRC, please mention the name of the projects, their location, type of work, amount of contract in USD, starting date & completion date.
- f) List of previous works including any certificate or document proving the type of work must be mentioned and range of contract amount (contract currency such as USD or IQD or other), their location and the Client.
- g) Other relevant & information document.

The bidder should sign each paper of tender initially at the lower right corner of the papers, in addition to the main signature and stamp wherever indicated.

**The bidder may quote for other technical solutions than the ones described in the bill of quantity. In this case, the necessary drawings must be produced and attached to the offer.**

#### 4. SPECIAL CONDITIONS

- The quantities in the Bill of Quantities are not fixed, and may vary according to the measurements of work actually carried out.
- Detailed situation reports and photos are to be produced weekly and submitted to the client.
- The contractor must dedicate an engineer for the entire duration of the rehabilitation period.
- All work shall be guaranteed under full warranty for period of **Three** months.

#### 5. SUPPLY OF MATERIAL

- All construction materials supplied by the Contractor (sand, gravel, bricks, all electrical & mechanical items... etc.) to be brand new, of best available quality in the market, in line with Iraqi specifications for such works.
- All materials are to be approved by the ICRC engineer (samples of all materials are to be provided before supplying).
- The items' description in the BoQ includes "supply of material, manpower, transportation, equipment, tools, machinery, etc." and all that is required to complete the works.

**6. PAYMENTS**

- Payments are made in **United State Dollars** (USD), on monthly basis based on the progress of the works according to the BoQ and measured on site by the representative of the ICRC.
- All requests for payments must be authorized by the ICRC engineer.
