1. SUBJECT

Btera CUs / Intakes / Rehabilitation, Amara, Missan

2. OBJECT

- Supply and install one Q 225m³/h, H 20m horizontal pump e-end type for Intake 2;
- Supply and install two Q 650m³/h, H 20m horizontal pump for Intake 3;
- Supply and install three Q 225m³/h, H 20m submersible pumps for Intake 4;
- Supply and install 1250A change over switch with other electrical parts;
- General improvements for the three intakes by replacing pillars and other parts.

3. TENDERING DOCUMENTS

The present Call for Tender comprises:

- The Call for tender itself
- The Bill of Quantities
- The technical drawings
- The works specifications
- The general conditions of ICRC

4. TENDERS

It is **compulsory** to complete the following points to fulfil the tender requirements:

- 4.1 The present Call for Tender signed by both the Company and ICRC representative during the Site Visit.
- 4.2 The complete Bill of Quantities (BOQ) signed and stamped.
 - 4.2.1 with unit prices for each item,
 - 4.2.2 with duration of the works (in days).
 - 4.2.3 with total cost.
- 4.3 A detailed Work Schedule.
- 4.4 The drawings signed.
- 4.5 The works specifications signed
- 4.6 The general conditions of ICRC signed and stamped.
- 4.7 A presentation & certification file, including:
 - a) an introduction letter with company's or bureau's logo), name, address, phone no., email, bank account & branch, full first 3 names of director and a copy of his/her valid ID :
 - ⇒ for **Companies** : Ministry of Planning & Developmental Cooperation -Iraqi Contractors Registration ID
 - ⇒ for **Bureaus** : Ministers' Counsel's Planning Committee - Iraqi Contractors' Registration ID or a registration from a governorate Chamber of Commerce for Contractors in a relevant field of activity (dealers & suppliers not accepted) or Iraqi Contractors Federation ID
 - b) a copy of Director's or, if existing, representative's ID (passport or National ID).
 - c) for **companies**, copy of Company Incorporation & Company Incorporation Certificate issued from the Ministry of Trade includes number & date of registration.
 - d) In case of previous works with ICRC, please mention the name of the projects, their location, type of work, amount of contract in USD, starting date & completion date.
 - e) list of previous works including any certificate or document proving the type of work must be mentioned and range of contract amount (contract currency such as USD or IQD or other), their location and the Client.

- f) list of permanent staff includes, name, speciality & number.
- g) list of Company/Bureau's equipment & machinery with the details
- h) other relevant & information document.

The bidder should include his initials at the lower right corner of each page of the tender documents, in addition to the main signature and stamp wherever indicated.

All correspondences must be in English language.

All received offers will be dealt with confidentially.

Any changes in the offers by the bidder must be received in the same way of offers submission and prior to the closing date.

All offers not following the above-mentioned clauses will be disqualified.

All participating bidders will be notified of the result of the selection process as soon as it is concluded. ICRC is not liable to provide any explanation for its final selection of the bidder.

For the successful bidder: acceptance and signing of the contract entails the waiving by the bidder of its General Conditions of sales/works.

The bidder may quote for other technical solutions than the ones described in the bill of quantity. In this case, the necessary drawings must be produced and attached to the offer.

All conditions not mentioned herein shall be governed by the General conditions of ICRC.

5. SPECIAL CONDITIONS

- The quantities in the Bill of Quantities are not fixed, and may vary according to the measurements of work actually carried out.
- Detailed situation reports and photos are to be produced weekly and submitted to the client.
- The contractor must dedicate an engineer for the entire duration of the rehabilitation period.
- All work shall be guaranteed under full warranty for period of 12 months.

6. SUPPLY OF MATERIAL

- All construction materials supplied by the Contractor (sand, gravel, bricks, all electrical & mechanical items, etc.) to be brand new, of best available quality in the market, in line with Iraqi specifications for such works.
- All materials are to be approved by the ICRC engineer (samples of all materials are to be provided before supplying).
- The items' description in the BoQ includes "supply of material, manpower, transportation, equipment, tools, machinery, etc." and all that is required to complete the works.

7. PAYMENTS

- Payments are made in **United State Dollars (USD)**, **on monthly basis** based on the progress of the works according to the BoQ and measured on site by the representative of the ICRC.
- All requests for payments must be authorized by the ICRC Engineer.
