Transport costs are included in the product prices.

Delivery time:

The delivery time of the goods after ordering must be stated. All ordered goods must latest be delivered at the date stated in the bid. In the event of late delivery goods may not be accepted by us.

Prices:

Prices shall be free of taxes and other public charges. The prices shall include the costs for goods, Transportation, packing, marking, and insurance and all other local costs incidental to deliver the goods to the final destinations.

Bid Currency, Validity and Language:

Prices shall be quoted in USD.

Bids showing other currencies may not be considered.

Bids shall remain valid for 30 days after the deadline for submission of bids.

The language of the bid shall be English.

Payment of goods will be done within 15 working days after taking over of the goods/services at the address as stated in the purchase order.

Payment may be done by cash, cheque or bank transfer at GIZ Project Offices.

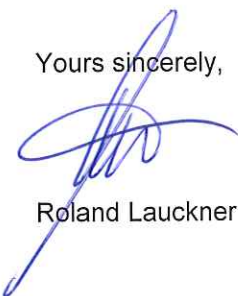
