**Prices:**

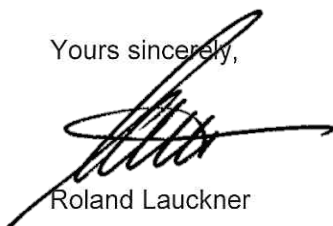
