Reconstruction of two storage warehouse for agricultural products in Tal-Abtah - sub district - Ninewa government

1. PROJECT BACKGROUND

- a. **Project description:** The objective of the reconstruction of two storage warehouse, is to reintroduce the agricultural services that were there before, e.g., store used to house a mobile seed purification plant, providing pure seeds for the agricultural season, The building is owned and operated by Ministry of Agricultural, Ninewa Governorate.
- b. **Direct and indirect beneficiaries**
 - i. Direct beneficiaries: 15 dept of agriculture employees
 - ii. Indirect beneficiaries: 2,000 houses and a population of around 10,000 people (4,000 male and 6,000 female)
- c. **Impact after completion:** the impact will be measured by the resumption of extension training, cleaning and distribution of seeds and an enhanced more efficient agricultural sector
