PROJECT NAME: **ARILA project (Assisting Reconstruction and Improving Living Conditions in Anbar) Construction Component**

WORKS: **Construction/Establishing of Municipality Buildings, a Nursery and a Football Court Cities of Fallujah, Ramadi and Heet.**

The Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH is commissioned by the German Federal Ministry for Economic Cooperation and Development to implement the program: **“ARILA project (Assisting Reconstruction and Improving Living Conditions in Anbar) in Anbar, Iraq”**

The Projects main objective is the improving of the Living Conditions in Anbar. It has different components to reach the project goal. Objective of the project is to strengthen state citizen dialogue through the joint assessment and identification of basic needs regarding basic infrastructure in selected communities. Sub objectives relevant for this part of the project are a) Improving infrastructure conditions in Anbar, b) Support the regional Government in Anbar through infrastructure projects; c) improving living conditions in Anbar and d) Improving recreation locations especially for the young people in Anbar.

The component of the ARILA project (Assisting Reconstruction and Improving Living Conditions in Anbar) who especially implements the improving of basic infrastructure in the project area is the Construction Component. Identification of construction projects is done by cooperating organizations like Mercy Corps and NRC. Through them ARILA Construction Component received a list of construction projects which will be implemented by ARILA.

Objective:

The project calls for Construction/Establishing of Municipality Buildings, a Nursery and a Football Court **Cities of Fallujah, Ramadi and Heet in Anbar.**

- Construction of Municipality Buildings
- Establishing of a Nursery
- Establishing of a Football Court

Therefore, GIZ is looking for adequate and experienced companies who must be able to offer following activities:

Municipality Buildings:

Construction of Municipality Buildings as whole construction with all required works according designs and BoQ's. This have to be executed according to international standards with high quality and durable materials/equipment, implemented by specialized skilled workers.

All activities must be closely coordinated with GIZ ARILA Construction Component. Work includes:

- 1) Site establishment and running of construction site
- 2) Secure the side during time of construction/installation

- 3) Supplying, of all materials according to specification
- 4) Earth work according to design/BoQ/specification
- 5) Concrete work according to design/BoQ/specification
- 6) Brick work according to design/BoQ/specification
- 7) Installation work (electrical/mechanical) according to design/BoQ/specification
- 8) Finishing work according to design/BoQ/specification
- 9) Provide training and Documents for Operation and Maintenance related to the facility

Nursery:

Construction/Establishing of Nursery as whole construction with all required works according designs and BoQ's. This have to be executed according to international standards with high quality and durable materials/equipment/devices, implemented by specialized skilled workers.

All activities must be closely coordinated with GIZ ARILA Construction Component. Work includes:

- 1) Site establishment and running of construction site
- 2) Secure the side during time of construction/installation
- 3) Supplying, of all materials according to specification
- 4) Earth work according to design/BoQ/specification
- 5) Concrete work according to design/BoQ/specification
- 6) Brick work according to design/BoQ/specification
- 7) Installation work (electrical/mechanical) according to design/BoQ/specification
- 8) Finishing work according to design/BoQ/specification
- 9) Supply and installation of greenhouses according desig/BoQ and specifications
- 10) Gardening work
- 11) Provide training and Documents for Operation and Maintenance related to the facility

Football Court:

Construction/Establishing of Football Court as whole construction with all required works according designs and BoQ's. This have to be executed according to international standards with high quality and durable materials/equipment/devices, implemented by specialized skilled workers.

All activities must be closely coordinated with GIZ ARILA Construction Component. Work includes:

- 1) Site establishment and running of construction site
- 2) Secure the side during time of construction/installation
- 3) Supplying, of all materials according to specification
- 4) Earth work according to design/BoQ/specification
- 5) Concrete work according to design/BoQ/specification
- 6) Supply and establishing of artificial gras according to design/BoQ/specification
- 7) Installation work (electrical/mechanical) according to design/BoQ/specification
- 8) Finishing work according to design/BoQ/specification
- 9) Supply and installation of lightning for the Football Court according desig/BoQ and specifications
- 10) Gardening work
- 11) Provide training and Documents for Operation and Maintenance related to the facility

Duration of the rehabilitation/construction work

The program intends to implement several projects for Municipality Buildings, a Nursery and a Football Court. Therefore, a general timeline can be given only as follow:

Times of tender will start around midst of April with the first project and will ongoing until November 2023 with the last project.

Tender Period for several tenders in the time of **April 2023 until October 2023**. For each tender including contracting a period of **3 to 4 month** is expected.

Project implementation for the different project is planned between **July 2023 until June 2024**. Depend on the size of the project an entire time of implementation is **planned between 4 to 8 months**.

To qualify for consideration in the tender procedure, interested companies are required to submit the following information and documents for eligibility assessment:

- **Administration Required Documents:**

- Official letter expressing interest
- Company local registration certificate
- Bank data with all details from a local bank (Bank Name, Account Holder, IBAN).
- Valid Grading of Contractor from ministry of planning.
- Annual turnover within the last three (3) years.

- **Technical Eligibility required documents:**

- Company profile including number of employees (permanent / temporary in total) and number of professional staff qualified to perform the works (**Construction/Civil Engineering**), each for the last three (3) years.
- References of works of similar nature as specified above (performed within the last three (3) years)
- Total value of works of similar nature as specified above (for each of the last three (3) years)
- Evidence of ownership of equipment and machinery necessary to execute the works or evidence of possibility to hire/rent equipment and machinery.
- Ability to provide the Service for Operation & Maintenance training (yourself or through the use of a specialist provider)

Deadline:

Interested companies must submit above mentioned documents and the full contact details of their company within specified date until:

30th March 2023 at 17:00

This expression of interest is a market filter for identifying qualified design companies that are specialised for construction and fitting out of commercial dining facilities.

GIZ maintains the right for appropriate selection of companies based on GIZ internal audited regulations for procurement and contracting in regard of any possibility for a further tendering process for the abovementioned services.
