

Announcement of Tender No. ((26 /2024))

S / supplying Premix

1- The General Company for Grain Processing is pleased to announce for the first time a tender for (supplying (1000) one thousand tons of premix material.

2- The General Company for Grain Processing has the financial allocations within the (governing expenses) and intends to use part of it to implement the supplying of the premix material.

3- Bidders who wish to buy tender documents can submit a written request to the (General Company for Grain Processing / Legal Department) after paying sale value of the non-refundable documents amounting to (1,000,000) one million dinars by certified check from governmental banks, Bidder who wish to have more information can contact the mentioned address

, Bidders who wish to have more information can contact the address above.

4- Receive the bids to the following address (General Company for Grain Processing / Office of the General Manager located in Baghdad Governorate / Aden Square / Entrance to Al-Hurriya City) in a date (maximum at (10 :00) a.m. on day 5 / 11 /2024 according to Baghdad timing) . The late bids will be rejected and bids will be opened in the presence of the bidders or their representatives who wish to attend at the same time, date and address.

Bids must include the following: -

1- Certificate of incorporation of the company submitting the bid, along with a release of renewal fees from the Companies Registrar Department. If the company is established outside the country, an incorporation license must be submitted, certified by the Commercial Attaché at the Iraqi Embassy in the country of incorporation and certified by the Iraqi Ministry of Foreign Affairs.

2- Initial insurances is presented by a certified check or or performance bond in the amount of (152,100,000) one hundred and fifty-two million and one hundred thousand Iraqi dinars, or its equivalent in Iraqi dinars that represents a ratio of 3% of the estimated cost, from the Iraqi Trade Bank or one of the government banks or one of the banks approved by the Central Bank and editor for the order of the General Company for Grain Processing by the company submitting the bid or one of its shareholders, and its validity not less than (35) days from the date of expiry of the bid's validity, which is 120 days from the date of closing tender.

3- Submit no – objection letter from participating in tenders from the General Authority for Taxes for the year 2024 and addressed to the General Company for Grain Processing exclusively (the tenderer should committee to bring clearance book when getting contract except forging companies).

4- Receipt of the tender terms.

5- Providing similar works.

6- In case of presenting photocopied documents, they must be certified and stamped as the original version from the issuing authority and regarding to the identification documents (the unified card, Civil Status Identity, nationality certificate, housing card, etc.) Conformity with the original upon assignment

7- The conference will be held to answer the queries of the participants in these tenders at (10:00) a.m according to Baghdad time , on day 29 / 10 /2024 at the company's headquarter / legal department / contracts division.

8- In case of that the closing day of the tender coincides with an official holiday, the next day will be the date for receipt and opening of bids.

Note: the estimated cost is ((3900 \$)) three thousand and nine hundred dollars per ton.
